When a child marries or reaches the age of 21 years, unless in the military or full-time student, a new immediate family is formed. If they are in the military or full-time student, an individual membership starts at age 25. Membership fees are due and payable no later than February 15th or on the date of the first BCSC playday. If a membership application is received after this date, there will be a \$25 late fee for AASP&RC dues.
